Record

A Record of Activism, Democracy, and Effectiveness

The current New Caucus leadership of the BMCC PSC, led by Jane Young as Chapter Chair, took office on September 1, 2001—a mere ten days before 9/11. During the past tumultuous five and one half years, we have built a chapter that has been active, democratic, and effective in defending the professional prerogatives and working conditions of all the faculty and staff on campus.

Among Our Accomplishments Are:

Among Our Accomplishments Are: **PROTECTING OUR HEALTH, SAFETY AND WELLBEING AT BMCC** ►Brought in an outside environmental consultant to monitor the air, and our health and safety, and to meet with BMCC and CUNY administrators in the wake of 9/11. ►Brought in the National Institute for Occupational Health and Safety (NIOSH) to survey the effects of 9/11 on faculty and students. ►With the active assistance of City Council members such as Alan Gerson, helped win funding for the demolition and rebuilding of the Fiterman Building. ►Continued oversight and monitoring of health and safety of demolition process, attending CUNY hearings in November 2006 and February 2007. Jane Young, our Chapter Chair, was elected member of CUNY Advisory Committee on Fiterman Hall (2006-2007). ►Gathered over 6,000 signatures on a successful petition (2002-2003) that got the CUNY administration to repair and rebuild elevators and escalators at BMCC. ►Waged a successful campaign with the administration and faculty/staff to get the CUNY Central Administration to commit to replacing our outdated and dysfunctional Heating and Air Conditioning System by 2010, and to installing three new "chillers" (2007-2008). **FIGHTING BUDGET CUTS AND FOR A BETTER CONTRACT** ►Testified at numerous hearings about the state and city budget, tuition increases, as well as post 9/11 health and safety and space problems at BMCC. ►Organized a delegation of 50 from BMCC to the NYSUT rally in Albany (Spring 2003) protesting statewide budget cuts in education. ►Collected 17,000 postcards signed by BMCC students and faculty protesting budget cuts in Albany and urging investment in CUNY (2003). ►Joined student protests of tuition increases (2002-2006). ►Organized over 100 BMCC faculty/professional staff to attend the PSC mass contract meeting at Cooper Union (Sept. 29, 2005). ►Sent BMCC representatives to observe contract negotiations (2002-2006). Page 1 of 2/see reverse side **DEFENDING OUR PROFESSIONAL LIVES AT BMCC** ►Campaigned to relieve overcrowding for full-time and part-time faculty in the wake of 9/11, winning additional

space for classes and offices. ► Won the right of faculty to participate in Childcare Network of Manhattan, Bronx, Brooklyn and Queens (2004). ► Held CUNY Week demonstrations, panel discussions and presentations (2002—2006). The most recent CUNY Week (March 2006) included presentations and films on Race and Hurricane Katrina, and the De-funding of Public Higher Education. ► Successfully campaigned to maintain the Faculty Cafeteria in 3rd Floor Dining Room. ► Organized a successful petition campaign (2003-2004) to increase the number of Faculty Counselors at BMCC. ► Supported Faculty Counselors who were protesting the proposed creation of new HEO Counselor title in recently negotiated PSC contract. The Chapter unanimously passed a resolution against the creation of HEO Counselor title (April 20, 2005), which was presented at the PSC Delegate Assembly (April 21, 2005). ► Organized a meeting of adjunct representatives with department chairs (December 7, 2004). ► Organized a meeting of department chairs and the Chapter Executive Committee concerning summer pay (2004). ► Pressured administration to dramatically increase the number of sabbaticals at BMCC—from one or fewer sabbaticals in the years preceding 2001, to seven in 2003. In 2005-2006, there were five sabbaticals, of which three were fully paid half-year leaves. ► Won an Administration-organized Adjunct Orientation for Fall 2007; campaigned for rights of adjuncts in terms of pay, space, facilities, and overall treatment by department chairs. ► Provided effective, knowledgeable grievance counseling to dozens of BMCC faculty and staff, with positive outcomes in many cases. ► Organized a campaign to encourage the administration to show respect for faculty and staff in a variety of areas. The fruits of this campaign include the Holiday Party (December 18, 2006) jointly organized by the administration, PSC and Faculty Council; and the new policy on new faculty reassigned time, which ends the process of administrative approval (February 2007).

ORGANIZING A DEMOCRATIC CHAPTER ► Organized a Contract Enforcement Committee with departmental representatives. ► Held monthly chapter meetings with attendance ranging from 40 to over 100 faculty and staff. ► Published union newsletter, The Gadfly, two or three times each semester.

Ten Reasons to Re-Elect the BMCC New Caucus Slate

1. Fought successfully to ensure the health and safety of faculty, staff, students, and downtown residents in the wake of 9-11, and to relieve overcrowding at BMCC.
2. Fought successfully to win funds to repair BMCC infrastructure—including the elevators and escalators, and the outdated Heating and Air Conditioning System.
3. Worked with other city unions and downtown residents and business groups in an ongoing effort to insure the safe demolition and reconstruction of Fiterman Hall.
4. Increased the visibility and status of part-time faculty.
5. Fought successfully to (a) remove the bureaucratic administration application form that obstructed contractually mandated reassigned time for new faculty and (b) to expand the number of sabbaticals for senior faculty.
6. Supported faculty counselors in opposing the creation of the HEO counselor position in the latest PSC-CUNY Contract and petitioned the BMCC administration to increase the number of faculty counselors.
7. Worked with students and other citizens to protest budget cuts and tuition increases in the past four years, collecting 17,000 postcards from BMCC faculty, staff and students.
8. Won the right of faculty to participate in the Childcare Network of Manhattan, Bronx, Brooklyn, and Queens.
9. Expanded chapter membership by more than 50% in six years.
10. Built an active, democratic, and inclusive

chapter whose activism was recognized by New York State United Teachers (NYSUT) when it awarded Jane Young the NYSUT member of the year award.

DIVERSE LEADERSHIP FOR A DIVERSE CUNY

Overview:

Dear HEO Colleagues: We are proud to represent you to CUNY management. We know of HEOs great value to this university and we are pledged to protect and further develop the contractual foundations of HEOs professionalism. We are the university's first responders, working day, night and weekends in the admissions and bursars offices, at the registration sites, at the counseling and advisement centers, in financial aid, at the Educational Opportunity Centers, in the SEEK and College Discovery Programs, at the childcare centers, in the libraries and information technology offices - we are there, maintaining the special services that make it possible for students to survive. In our everyday work-lives, most of us work collaboratively with management. The union contract provides the necessary supports for such collaboration with its provisions for salary steps and salary scales equal to faculty ranks, 13.3(b) job security protections, due process rights, professional development grants – to name a few. When management steps out of line and tries to undermine the basis for collaborative work, as they did in the last negotiations by trying to undermine 13.3(b), we stood up to management to protect our rights. When our working conditions undermine professionalism, like long hours of unpaid overtime, we stood up to management to enforce the federal Fair Labor Standards Act and the provisions of our contract. We know that much more needs to be done in this round of bargaining to insure our professionalism – higher salaries, promotional opportunities, better due process protections – and you need representatives who will stand up to management to win these. We ask you to stand with the people who will stand up with you to achieve our rights. Twelve Reasons to Re-Elect the New Caucus

- Achieved the best PSC salary increases in a decade in the 2000-2002 contract.
- Secured an equity pay increase for Assistant to HEO title and added money for those at the top step (2000-2002).
- Instituted campus labor-management teams to consider reclassification and workload issues.
- Negotiated the first professional development fund for CUNY staff and increased the fund to \$3000.in the recent contract. In just the first year over 358 HEO's have used the fund and hundreds more are receiving grants now.
- Defeated management's attempt to weaken job

security (13.3 b) and decrease the HEO pay scale. ►Increased dramatically the rate of success for HEO grievances filed and HEO Grievance Officers are available 4 days per week at the PSC office. ►Elected a HEO as a PSC officer, for the first time, and increased HEO representation throughout the union with more HEO's on the Executive Council, the Negotiating Team, and the Grievance Policy and Contract Enforcement Committees. ►Engaged in major litigation to secure compensation for work over 35 hours and overtime pay as appropriate. ►Strengthened the Welfare Fund and improved dental benefits. ►Enforced health and safety standards to better protect members and students. ►Protected members' rights to Travia leave through an arbitration victory. ►Reversed twenty-year trend of declining State and City funding for CUNY, which is essential to achieving our goals.

Twelve Reasons to Vote New Caucus/CCNY

1. Won major faculty grievances, particularly around promotions
2. Helped the PSC gain a contract that provides 80% paid sabbaticals for tenured faculty, 12 hours released time for junior faculty, and keeps department chairs in the bargaining unit. After five years of 0 % increases, the chapter helped negotiate increases consistent with settlements received by other NYC municipal labor unions.
3. Maintained constant pressure on the administration to respect faculty governance.
4. Worked with faculty governance groups and the administration to alleviate the parking crisis of 2007, but the chapter vigorously continues to seek solutions to this on-going

problem. 5. Demanded solutions to the deteriorating physical structure and unhealthy working conditions of Marshak. 6. Helped the PSC achieve pension equity for TIAA/CREF members with TRS: after ten years of service, contributions to TIAA/CREF will be paid by the university; beginning this spring participants should notice an increase in pay as a result. 7. Defended the faculty's, the staff's, and the student's right to free speech in public forums on campus, and fought for the reinstatement of students and a staff member arrested in March, 2005; ended the penning of faculty, student, and staff demonstrators during campus protests. 8. Obtained a faculty lounge open every weekday. 9. Spearheaded the successful effort for in-state tuition for immigrants who attended at least two years of a New York State high school, enabling thousands of deserving students to obtain a college education. 10. Helped achieve paid office hours for adjuncts and initiated significant organizing efforts on their behalf. 11. Inspired and motivated the administration to provide a greener campus environment. 12. Lobbied Albany and City Hall with the community and other labor unions on behalf of our members and are now struggling to achieve paid family leave.
